Articles of Incorporation of

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: Provide assistance, encouragement and support to the cadet sons and daughters of the members, Provide information and assistance to each other in matters pertaining to the cadets. Provide information and encouragement to parents of prospective USAFA Southwest Florida Parents! Club, Inc. cadets.
