Article VIII

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of sections 501c3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
