

ARTICLE III

Section 1:

This corporation is organized and operated exclusively for one or more of the following purposes: Charitable, Educational, Scientific and/or Religious. This includes the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The specific purpose is to provide the following services: 1) Helping any unemployed person of the age of fifty (5) years or older to be reincorporated to a productive life in the job market, 2) Enhancement of quality of life for individuals as they grow older, 3) Furthering independence, dignity and purpose for individuals as they grow older, 4) Improving the image of aging. Section 2:

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of the document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Section 3:

The Prime Dynamic Foundation may be dissolved by two-third (2/3) vote of the Board of Directors. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for religious, charitable, educational, literary, and scientific purposes and which has established its tax exempt status under Section 501 (c) (3) Internal Revenue Code.

ARTICLE IV:

The manner in which the Directors are elected or appointed:

- Eligibility. Members of The Prime Dynamic Foundation Board of Directors shall be forty-five (45) years of age or older and posses a college or higher education degree.
- 2. Number. The number of Directors of the Board of The Prime Dynamic Foundation shall be no less than the number required pursuant to the Florida General Corporation laws.
- 3. Terms. At the beginning of the biennium, which is a spring meeting of each evennumbered year, the Board of Directors shall elect a minimum of seven (7) directors to serve for a term of six (6) years. The Board of Directors shall establish a procedure so that one-third (1/3) of the membership of the Board of Directors is elected each biennium. Present and future directors are and shall be eligible to serve and complete one (1) term.
