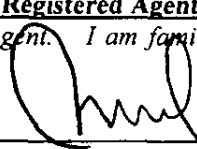

ARTICLE I

Name

The name of the nonprofit shall change from "The Prime Dynamic Foundation, Corporation" to "Tree of Hope Foundation, Corp."

ARTICLE III

Purpose

The Tree of Hope Foundation, Corp. is organized and operated exclusively for one or more of the following purposes: **Charitable, Educational, Scientific, Social and/or Religious**. This includes making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. **The specific purpose is to provide direct and indirect charitable services to children, veterans, and homeless in poverty, including medical, legal, educational, adoption, shelter, and religious assistance.**

ARTICLE IV

4. Exclusion. The founder and co-founder of the Tree of Hope Foundation, Corp. are excluded from the Provisions 1, 2, and 3, in this ARTICLE IV. The founder will serve the office of the Chairman of the Board for life time. The co-founder will serve the office as a Vice-Chairman of the Board for life time, and will serve the office of the Chairman of the Board for life time if the founder resigns voluntarily, dies, or become mentally disabled.

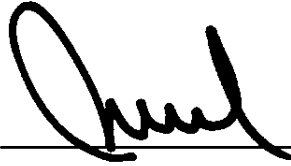
