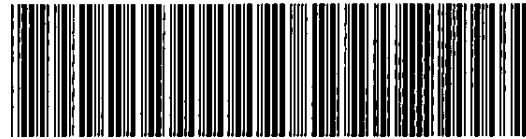

A FLORIDA NONPROFIT CORPORATION**

ARTICLE I – CORPORATE NAME

GOOD MEN GIVING BACK, Inc.

ARTICLE II – CORPORATE NATURE

This is a nonprofit corporation, organized solely for general charitable purposes pursuant to the Florida Corporations Not for profit Florida Law set in Part I of Chapter 617 of the Florida Statutes.

ARTICLE III – GENERAL AND SPECIFIC PURPOSE

Section One **GOOD MEN GIVING BACK, Inc**

Is organized and shall be operated exclusively for charitable, educational, community development and other related purposes, including, but not limited to, sponsoring, organizing, administering, enhancing and operating activities for the benefit of the City of Pensacola, Florida and surrounding communities.

Section Two. **GOOD MEN GIVING BACK, Inc** Is a not-for-profit corporation organized under Chapter 617, Florida Statutes. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its directors or officers, except to the extent permissible under the Articles of Incorporation and Bylaws, under law and under 26 U.S.C.A. § 501(c)(3) of the Internal Revenue Code. No private individual shall have any vested right, interest or privilege in or to the assets, income, or property of the Corporation and no part of the income or assets of the Corporation shall be distributable to or for the benefit of private individual, except to the extent permissible under the Articles of Incorporation, Bylaws, under law and under 26 U.S.C.A. § 501(c)(3) of the Internal Revenue Code.

ARTICLE IV - COMMENCEMENT AND DURATION

The corporation is to commence its corporate existence on the date filed with the Florida Secretary of State's office and shall exist perpetually thereafter until dissolved according to law.
