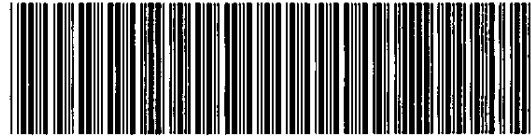

ARTICLE V No part of the net earnings of the corporation shall insure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth.

No substantial part of the activities of the named Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in , or intervene in including(distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these , the corporation shall not carry on any other activities not permitted to be

carried on (a) corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code or (b) by a corporation , contributions to which are deductible under section 170(C)(2) of the Internal Revenue Code, or the Corresponding section of any future federal tax code.

NOTE: Notwithstanding any other provision of these articles , this Corporation shall not except to an insubstantial degree engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation

ARTICLE VI Directors: Shall be elected or appointed by the church body to serve a one year term. If an elected/appointed board member cannot complete his/her term the board shall by majority appoint an interim board member to fill the vacancy till

shall be distributed to the federal government or




