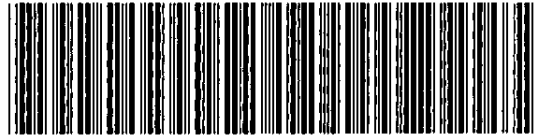

Article III

1. The specific and primary purpose for which the corporation is organized is to provide spiritual help and services to the community and the members of the church to provide knowledge of God and his son Jesus Christ. The additional purpose of the organization is to promote and provide in accordance with the Non Profit status , regular spiritual guidance , group therapy counseling, as well as meals , prevention intervention outreach components , and services to those in need . To establish self-help programs for homeless and socially handicapped individuals. To provide housing opportunity, shelter, emergency, and independent living skills.
2. To dedicate our ministry to help in childcare assistance, senior assistance, and veteran services.

Article VI

Statement of Purpose:

The corporation is organized exclusively for charitable, education and scientific purpose within the meaning of section 501(c) (3) of the Internal Revenue Code 1986 as amended on the corresponding provision of any future Internal Revenue laws for specially stated purposes defined in Articles of Incorporation, excepted as limited by the Articles of Incorporation. And, by their bylaws, the corporation shall have and exercise all rights and powers in furtherance of its purposes as or now may hereafter are conferred a Not-for-Profit corporation under the law of the state of Florida.

Article VII

Activities:

- A. No part of the net earnings of the corporation shall inure to the benefit of or be distributable to any member , director or officer of the corporation or any private individual except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes. NO member, Director or Officer of the corporation, or any private individuals shall be entitled to share in the distribution of the corporate assets or dissolution of the corporation. However, the corporation may confer benefits in the form of the distributions in dissolutions or otherwise upon any not-for-profit corporation described in section 501 (c) (3) and section 170(c) (2) of the code and specified in section 4.3 below. NO substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in any political campaign (including the publication or distribution of statements) on behalf of a candidate for public office.
- B. Notwithstanding any other provisions of these bylaws , this organization shall not conduct or carry any activities not permitted to be conducted or carried on by any organization exempt from taxation under section 501(c)(3) of the Internal Revenue Code or by the organization in which contributions are deductible under section 170(c)(2) of the code .
- C. Upon dissolution of the corporation, the members of the corporation shall, after paying or making provisions for payment of all liabilities of the corporation from residual assets of the corporation shall distribute all remaining residual assets to the federal, state

or local government for exclusive public purpose. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction exclusively for such charitable purposes or to such organizations organized and operated exclusively for such charitable purposes as the courts determine.
