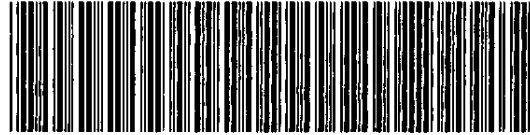

ARTICLES OF INCORPORATION
In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: Universal Christian Sovereign Life Church, Inc.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- A The purpose of this organization is to be the kind of congregation (church) designed and described by Christ and the Apostles in the New Testament, and shall not be for the profit of itself, nor of any individual, nor of any organization.
B In carrying out the above-mentioned purpose, this congregation shall have an entirely independent status. It is not subject to, and neither shall it be controlled by, any state or national religious or missionary organization, nor by any external body or group.
C The congregation shall be limited to religious, charitable and educational activities within the meaning of Section 501(c)(3) of the U.S. Internal Revenue Code.
D The purpose and specifics in this article are not intended to be and shall not be held in limitation of the powers now or hereafter granted to this non-profit congregation under the laws of the State of Florida, but are intended to be and shall be in furtherance thereof.

ARTICLE IV MANNER OF ELECTION The manner in which the directors are elected and appointed:
