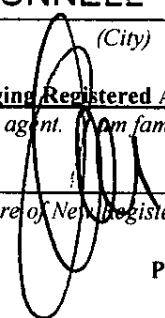

### ARTICLE III

THE PURPOSE OF GOD'S PEOPLE MINISTRIES INTERNATIONAL INC IS TO GLORIFY JESUS CHRIST AS A CHURCH ACCORDING TO THE PATTERN SET DOWN IN THE HOLY BIBLE. GOD'S PEOPLE MINISTRIES INTERNATIONAL INC IS ORGANIZED EXCLUSIVELY FOR THIS RELIGIOUS PURPOSE AND SHALL ONLY UNDERTAKE ACTIVITIES PERMITTED BY INTERNAL REVENUE CODE UNDER SECTION 501(C)(3). IF DSITRIBUTIONS ARE MADE BY GOD'S PEOPLE MINISTRIES INTERNATIONAL INC THEY WILL BE MADE TO ONLY OTHER QUALIFYING ORGANIZATIONS PER SECTION 501(C)(3) OF THE IRC, OR ANY CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.

### ARTICLE VIII

UPON THE DISSOLUTION OF GOD'S PEOPLE MINISTRIES INTERNATIONAL INC, ASSETS SHALL BE DISTRIBUTED FOR ONLY EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE. ASSETS MAY ALTERNATIVELY BE DISTRIBUTED TO THE FEDERAL GOVERNMENT OR TO A STATE OR LOCAL GOVERNMENT FOR A PUBLIC PURPOSE. ANY ASSETS NOT DISPOSED OF IN THE ABOVE MANNERS SHALL BE DISPOSED BY THE COURT OF COMMON PLEAS OF THE COUNTY IN WHICH THE PRINCIPAL OFFICE OF GOD'S PEOPLE MINISTRIES INTERNATIONAL IS AT THAT TIME LOCATED, EXCLUSIVELY FOR SUCH PURPOSE OR TO SUCH ORGANIZATION(S) AS SAID COURT SHALL DETERMINE, WHICH ARE ORGANIZED AND OPERATED EXCLUSIVELY FOR SUCH PURPOSES.

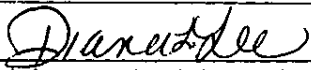
