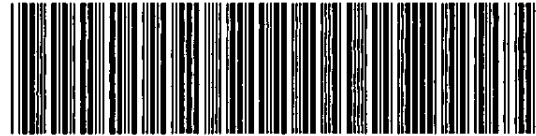

(d) In the event of dissolution or final liquidation of the corporation, the residual assets of the organization will be turned over to one or more organization(s) which themselves are exempt as organization(s) described in section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or Local Government for exclusive public purposes.
