In Compliance With Chapter 617, F.A., (Non-profit)

The Undersigned nonprofit of a Corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation of such Corporation:

## **ARTICLE I:**

The name of the Corporation shall be:

### **ARTICLE III:**

- a. Women in Motion 100, Inc.'s mission is to uplift and empower women through motivation, support, inspiration and networking. By doing this, we hope to improve the lives of members of our community.
- b. No substantial part of the activities of the Corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.
- c. The Corporation is organized exclusively for charitable, religious, educational and scientific purposes, the making of distribution to organizations that qualify as an exempt organization under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The period of the duration of this Corporation is filing with the Secretary of State unless dissolved according to law.

## **ARTICLE IV:**

The manner in which directors are elected or appointed is:

Elections shall be regulated by the By-Laws of the Corporation.

The qualification for members and the manner of their admission are; any person, corporation, company, association or organization, who are interested in the purposes of this Corporation, who are capable of contributing to the achievement of these purposes and the effective operation of this Corporation, and who complies with the requirements established from time to time by the By-Laws, and understand that this is a non-profit organization, shall be eligible for membership.

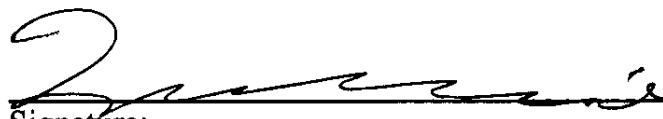

## **ARTICLE VIII:**

Upon dissolution of the Corporation, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170 (c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or Local Government for exclusive public purpose. Any such asset not so disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purpose or to such organization or organizations as said Court shall determine which are organized and operated exclusively for such purposes.

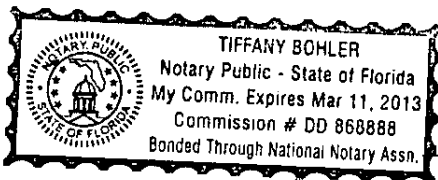

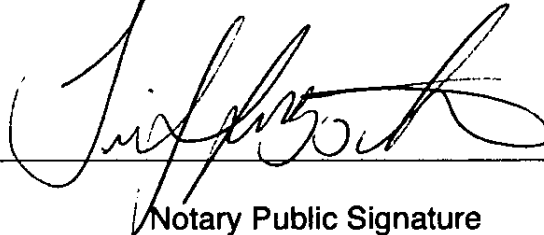
