ARTICLE III. PURPOSES AND POWERS

Said corporation is organized exclusively for charitable, educational, religious and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Said corporation shall operate within the guidelines and meaning of Section 501 (c)(3) of the Internal Revenue Code; To present a set of programs, projects, services, seminars and lectures pertaining to early childhood education and welfare; To provide early childhood education in preparation for elementary education and beyond; To instill the necessary skills for learning experiences; To prepare each child for the challenges of a technological world by teaching them basic skills; Imparting learning in all areas of practical life via experiential learning at different learning centers within the classroom; To expose the children to multiple indoor and outdoor activities, cultural enrichment, sports enrichment, field trips and other activities; To provide quality education for children of low to moderate income status.

No part of the net earnings of the corporation shall insure to the benefit of, or be distributed to its members, trustees, directors, officers and other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of the Articles, the corporation, shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.


