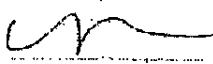

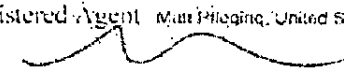
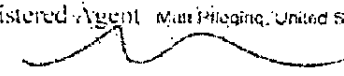

**Articles of Incorporation of**  
**Uniting Local Artists Inc.**

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: Uniting Local Artists, Inc. is a Non-Profit Organization that mobilizes professional artists – from musicians to artists to photographers to performers – in volunteer service programs that benefit youth in the local communities in the field of art. The primary mission of Uniting Local Artists, Inc. is to stage events that will spotlight local musicians and artist with community support. Uniting Local Artists, Inc. is the managing organization that pulls together companies to sponsor these events that will showcase local talent, while donating valuable musical instruments to local schools and hospitals. The first event created by Uniting Local Artists, Inc. is Pop-Up Piano Miami 2011. Pop-Up Piano Miami 2011 is a service event that is composed of Miami lovers of music and art, local entertainment companies, and professional artists who are volunteering thousands of hours because they believe art belongs to everyone. Steinway has donated 10 pianos to be painted by local artist and then these pianos will be positioned around Miami for free concerts by local musicians. Pop-Up Piano Miami 2011 mission is to promote live music, promote local artists, promote local musicians, and provide entertainment for the community. After the free concerts, the pianos will be donated to local schools and hospitals.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of this organization shall be the carrying on propaganda, or otherwise attempting to influence legislation, and this organization shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(e) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the

federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
