ARTICLES OF INCORPORATION FOR THE TORRES FOUNDATION, INC. (Not-For-Profit)

The undersigned, desiring to form a charitable corporation under Chapter 617, Florida Statutes, as amended, the Florida Not for Profit Corporation Act, does hereby adopt the following Articles of Incorporation and certify:

ARTICLE I NAME

The name of the corporation shall be THB TORRES FOUNDATION, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be-382 PAPAYA STREET, ST. JAMES CITY, PLORIDA 33956.

ARTICLE III PURPOSE

The corporation is organized exclusively to promote religious, acientific, literary, educational, and charitable purposes within the meaning of Section 501(0)(3) of the Internal Revenue Code of 1986, as amended, either directly or through other religious, scientific, literary, educational, or charitable organizations.
