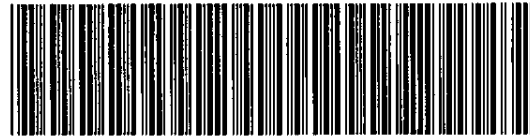

ARTICLES OF INCORPORATION

In compliance with Chapter 617 F.S. (Not for Profit)

Article I Name

The name of the corporation shall be: Dynamo Foundation, Inc.

Article III Purpose

The purpose of the corporation is to partner with socially conscious nonprofit organizations to create projects and events that will raise public awareness of their missions. The corporation is organized and will be operated exclusively for charitable purposes within the meaning of 501(c)(3) of the Internal Revenue Code. (All references to sections in these Articles refer to the Internal Revenue Code of 1986 as amended or to comparable sections of subsequent internal revenue laws.) In pursuance of these purposes it shall do all things necessary, proper and consistent with maintaining tax exempt status under section 501(c)(3).

Article VIII **Additional Provisions**

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept as registered agent and agree to act in this capacity.
