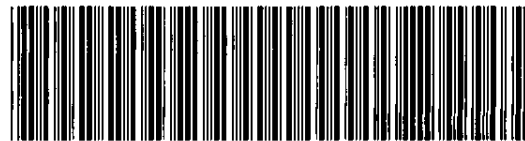

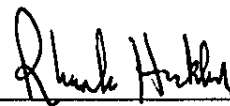

ARTICLE I
NAME

The name of the corporation shall be: NATIONAL ASSOCIATION OF REPAIR CONSULTANTS CREDIT REPAIR ADVISORS, INC.

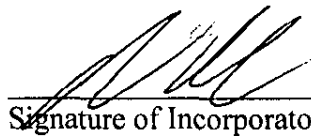
