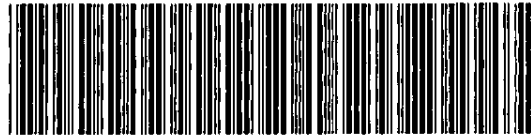

**ARTICLE 1 - NAME**

The name of the Corporation is **WOMEN & GIRLS ASSISTANCE ORGANIZATION INC.**, (hereinafter, "Corporation").

**ARTICLE 2 - PURPOSE OF CORPORATION**

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida mainly assisting women in need.




