ARTICLES OF INCORPORATION





<u>VIDA NOVA APOSTOLICA, INC.</u>

A FLORIDA NON-PROFIT CORPORATION, in compliance with Chapter 617 F.S.

The undersigned incorporators, being the Board of Directors of VIDA NOVA APOSTOLICA, INC., hereby state and adopt the following articles of such corporation:

ARTICLE 1 - NAME

The name of the Corporation is VIDA NOVA APOSTOLICA, INC. (hereinafter, "Corporation").

ARTICLE 2 – PRINCIPAL OFFICE

The place of business and mailing address of the principal office of this Corporation is 436 Lock Road Ste 94, Deerfield Beach, FL 33442.

ARTICLE 3 – OBJECT AND PURPOSE

This corporation is organized exclusively for charitable, acceptance and integration of different communities and cultures, educational purposes, including, for such purpose, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future tax code.

The object of the corporation shall be for the purpose of organizing, establishing and maintaining in Pompano Beach, a Ministry called Igreja Apostolica Vida Nova, declaring the Principles and Mission:

Preach the Word of God;

Travel the world and Preach the gospel to every individual;

Rescue the Lost Sheep;

Ministers & Levites:

Rescue the Ministers and Levites of the Lord who are lost;

Empower them with the Word and make them Disciples;

Open churches and put them to work for the kingdom doing the same (multiplication of the Lord, disciples creating disciples);

Deliverance/Rescue:

Cast Out demons, Deliver the captives and the oppressed from evil spirits;

Heal all Types of Infirmities;

Miracles:

Deliverance from Drugs;

Deliverance from Alcohol;

Deliverance from Depression, sadness, loneliness, anguish, desire of suicide;

Deliverance from the past, to be forgiven and to forgive;

Deliverance from Spiritual and material povety;

Visit Institutions:

Nursing Homes;

Prisons;

Hospitals in general: Where Disability Problems, Cancer, Aids, Children.

Rehab Centers:

Feed the Poor;

Clothe those who don't have clothes to wear;

Take care of children in need;

Take care of the youth in need;

Take care of the elderly in need;

Take care of Single Mothers in need;

Give support in general to Empower Families.

ARTICLE 4 – MEMBERSHIP

Those persons and entities accepted for membership in the VIDA NOVA APOSTOLICA, INC. shall adhere and subscribe to the Bylaws of this Church.

ARTICLE 7 - PROPERTY DEDICATED TO RELIGIOUS PURPOSES

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or the other private person, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not

participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future tax code.

ARTICLE 8 - IN EVENT OF DISSOLUTION

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1986 or corresponding sections of any prior future Internal Revenue Code, or to the Federal, or local government for exclusive public purpose.

ARTICLE 9 – POWERS OF CORPORATION

The Corporation shall have all the powers and rights conferred upon it by Statute, including but not limited to, the following: to receive, take, hold, lease, buy, sell, mortgage and convey real estate and personal property; to enter into, make and perform contracts of every kind; and to make, accept, endorse and issue promissory notes, and other negotiable or transferable instruments and evidences of indebtedness, whether secured by mortgage or otherwise, and as permitted by the Bylaws of the Corporation.

ARTICLE 10 - MANAGEMENT OF CORPORATION AND TIME OF ELECTION AND APPOINTMENT

The affairs of this Center shall be conducted and managed by a Board of Directors, consisting of no fewer of two (2) persons, with the number elected each year and the period of service to be as provided in the Bylaws of the Corporation. All members of the Center shall be entitled to vote for said directors. The officers of this corporation shall be established by the Bylaws. All said officers shall be elected by the Board of Directors in the manner provided by the Bylaws.

ARTICLE 11 - BYLAWS

The members of the Corporation shall have the right to make and adopt such bylaws as the shall deem proper and advisable, and they may be amended, altered or repealed by the Corporation members in accordance with the provisions in the Corporation Bylaws, as adopted.

ARTICLE 12 - TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE 13 -EFFECTIVE DATE

These Articles of Incorporation shall be effective immediately upon approval of the Secretary of State, State of Florida.



ARTICLE 14 – AMENDMENT

The Corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation, or in any amendment hereto, or to add any provision to these Articles of Incorporation or to any amendment hereto, in any manner now or hereafter prescribed or permitted by the provisions of any applicable statute of the State of Florida, and all rights conferred upon shareholders in these Articles of Incorporation or any amendment hereto are granted subject to this reservation.
