Attachment to Articles of Incorporation of Path To Success Corp.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: To provide assistance, counceling education and career training placement to young unwed mothers between the ages of 16-21.
