#### ARTICLES OF INCORPORATION

11 DEC -5 AMII: 08

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

## Article I: NAME:

The name of the Corporation shall be Our Children's Charitable Fund, Inc.

#### Article II: PRINCIPAL OFFICE

The place in this state where the principle office of the Corporation is to be located is 150 Avenue B SE, Winter Haven, Florida 33880

## **Article III: PURPOSE**

Said organization is organized exclusively for charitable purposes, under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future tax code, for the exclusive benefit of the current and future members of the Our Children's Network, referred to in Article IV. The corporation shall conduct its affairs such that it remains at all times an organization described in section 509 (a) (3) of the Internal Revenue Code, or the corresponding section of any future tax code.

#### Article IV: OUR CHILDREN'S NETWORK

- a) The Our Children's Network is more fully described as those current and future non-profit corporations meeting <u>all</u> of the following criteria:
  - 1. Organized exclusively for educational and charitable purposes under Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future tax code.
  - 2. Designated as a public Charter School, thereby eligible to receive funding thru the State of Florida, Department of Education.
  - 3. Operated under contract with any local school board in the State of Florida
  - 4. Governed by an elected board of directors common to all organizations
- b) The current members of the Our Children's Network are:

Our Children's Academy, Inc.

Our Children's Middle Academy, Inc.

#### Articles V: GOVERNING BOARD

The Board of Directors shall consist of those same individuals who are also officers of that certain Board of Directors common to the members of the Our Children's Network described in Article IV. The officers of that Board consists of Chairman, First Vice Chairman, Second Vice Chairman, Immediate Past Chairman, Secretary, and Treasurer. Election procedures to the common Board of Directors are contained in the by-laws of Our Children's Academy, Inc.

## **Articles VI: PROHIBITIONS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on or propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
