and Operation of low income elderly housing units.

This not for profit corporation is a wholly owned subsidiary of the Hialeah  
Housing Authority which is a public body corporate and politic  
formed pursuant to the provisions of Florida Statute 421.04.

The Hialeah Housing Authority is the sole member of HHA I, Inc., and has  
the authority to appoint the directors and officers of HHA I, Inc., and to  
direct its activities.

Moreover, the corporation (HHA I, Inc.) is specifically limited by  
the United States Department of Housing and Urban Development ("HUD") to  
developing real property owned by it for the construction of low income  
housing for the elderly and should the HUD requirements not be met  
the real property property owned by HHA I, Inc., is required to revert  
to the ownership of the Hialeah Housing Authority.
