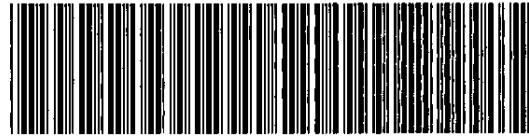

*Articles of Incorporation of*

**PRIORITY FOR THE DISABLED, INC.**

The undersigned, all of whom are citizens of the United States, desiring to form a Not for Profit corporation in compliance with Chapter 617, Florida Statutes, do hereby certify:

**Article I:** The name of the Corporation shall be PRIORITY FOR THE DISABLED, INC.

**Article II:** The principal office of the Corporation will be located at 7439 Mizner Reserve Ct., Lakewood Ranch, Florida 34202.

**Article III:** This corporation is organized for the purpose of promoting, supporting and engaging in the training of veterans, of the U.S. military branches, and other persons, with physical and mental disabilities, in the use of assistive computer technologies to enhance their employment opportunities. Said corporation is organized exclusively for charitable, educational and humanitarian purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation may engage in any activity or purpose permitted by law that is not inconsistent with, and is in furtherance of, the stated purpose for which the corporation has been organized.

**Article IV:** No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Article V:** Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**Article VI:** The corporation shall have a minimum of three directors. The names and addresses of the persons who are the initial Officers and Directors of the corporation are as follows:

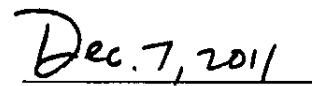
**Article VII:** The Board of Directors shall be elected or appointed as specified in the By-Laws of the corporation.

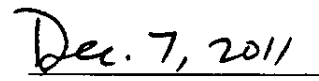
