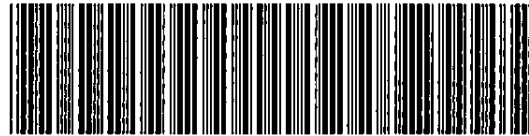

ARTICLES OF INCORPORATION

OF

TATTOO FOR PINK, INC.

(A Non-Profit Organization)

We, the undersigned have this 05 day of DECEMBER 2011, voluntarily associated ourselves together for the purpose of forming a non-profit corporation under the laws of the State of Florida, and hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the said non-profit corporation is **TATTOO FOR PINK, INC.**, herein after referred to as the "corporation".

ARTICLE II

The initial street address of the principal office of this corporation is 105-A North Oceanshore Boulevard, Flagler Beach, FL 32136.

ARTICLE III

The purpose of this corporation is to function as a not for profit organization, which raises capital to benefit women who have been afflicted by breast cancer. Available funds will be granted to women in crisis from breast cancer who cannot afford breast reconstruction procedures such as surgical implants and medical tattooing. These funds will also be used to provide other cosmetic needs to breast cancer patients such as permanent make-up, esthetician services, cosmetics, wigs, and hair extensions.

ARTICLE IV

The directors of the corporation shall be elected in accordance with methods and qualifications specified in the bylaws of the corporation. In no event, shall the number of directors be fewer than three.

ARTICLE VI

The name and address of the initial Registered Agent of this corporation shall be Tara Gower, whose street address is 3309 Beach Village Circle, Palm Coast, FL 32137.

ARTICLE VII

The name and address of the incorporator is:

ARTICLE VIII

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.


ARTICLE IX

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE X

The effective date for these Articles of Incorporation for Tattoo for Pink, Inc. will be the 1st day of January 2012.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity
