

ARTICLE III- PURPOSE

- 1) The organizational purpose of the Juni Albino Memorial, Inc. is to honor the memory of JROTC cadet Adrian A. "Juni" Albino. We will be accomplishing this goal by working to raise funds which will be used to provide scholarships to JROTC cadets at St. Cloud High School who demonstrate the traits and characteristics of selfless community service, dedication, courage, pride, academic excellence and respect as exhibited by Juni. ARTICLE VIII- DISSOLUTION

- 1) The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.
- 2) The manner of distribution of assets in this Corporation's winding up is as follows: Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal-Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or state or local government for public purpose.
