

ARTICLES OF INCORPORATION OF

King Henry's Independent Living, Inc.

A Non-Profit Corporation

THE UNDERSIGNED, acting as sole incorporator of King Henry's Independent Living, Inc. under chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

Name 1

The name of the corporation shall be King Henry's Independent Living, Inc.

ARTICLE II

Principal Office

The address of the Principal Office of the corporation is King Henry's Independent Living, Inc. 1115 Suncrest Drive, Apopka, Florida 32703. The location of the Principal office shall be subject to change as may be provided in bylaws duly adopted by the corporation.

ARTICLE III

Purpose and Powers

(1) The purpose for which the Corporation is organized and operated is exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501c3 of the internal Revenue Code,

- or the corresponding section of any future federal tax code. Such purposes shall include the following:
- (a.) To provide 24 hour care and housing for displaced and disable men and women.
 - (2) As a means of accomplishing the above purposes and methods, the Corporation shall have the following powers.

- (3)The property of the Corporation is irrevocable dedicated to educational and Charitable purposes, and no part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers or other private persons, except that the corporation/organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501c3 purposes.
 - (a.) No substantial part of the activities of the corporation/organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation/organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to any candidate for public office.
 - (b.) The Corporation shall not:
 - (1.) Operate for the purpose of carrying on a Trade or business for profit.
 - (2.) Accumulate income, invest income, or Divert income, in a manner endangering Its exempt status: or
 - (3) except to an insubstantial degree, engage In any activity or exercise any powers that Are not in furtherance of the purposes of The Corporation.

ARTICLE IV

Manner of Election

Board Members of King Henry's Independent Living, Inc. are nominated and elected by a quorum and serve as elected unpaid representatives for a term of three(3) years. Re-election is acceptable.

ARTICLE V
