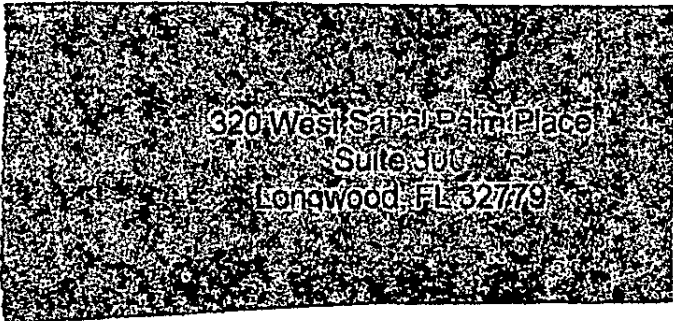

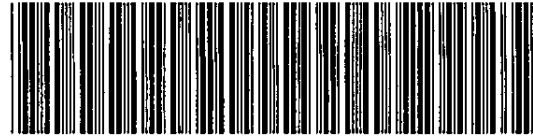

1. Article I of the Articles of Incorporation of the Corporation is hereby amended to change the Name of the Corporation to the following:


