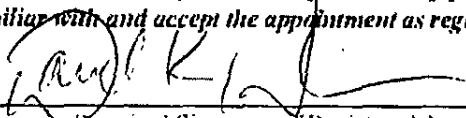

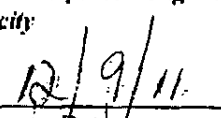
ARTICLE IX

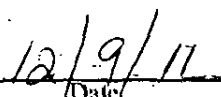
