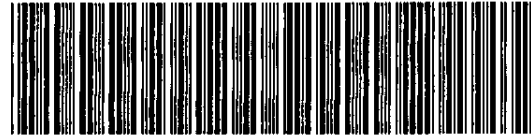





ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

INTERNATIONAL TRUMA LIFE SUPPORT OF FLORIDA, INC.

ARTICLE I - NAME AND ADDRESS

The name of this Corporation is: INTERNATIONAL TRAUMA LIFE SUPPORT OF FLORIDA, INC.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the Corporation is: 3717 SOUTH CONWAY ROAD, ORLANDO, FL 32812

ARTICLE III - PURPOSE OF BUSINESS

The Corporation is organized to advance and develop the body of knowledge of emergency trauma care and to promote education at all levels in this body of knowledge, including but not limited to the following:

1. To promulgate acceptable guidelines for quality emergency trauma care.
2. To encourage and facilitate the instruction of quality emergency trauma care courses.
3. To promote and encourage research in emergency trauma care.
4. To promote unity among the various levels of trauma care providers.
5. To promote the development and coordination of ITLS training programs throughout the state.
6. To promote and develop educational materials concerning emergency trauma care.
7. To address the standards of prehospital trauma care.
8. To administer local, state, and federal grants and funds granted or assigned for use by the corporation.
9. To be organized and operated exclusively for charitable and educational purposes according to Section 501(C)(3) of the Internal Revenue Code.

ARTICLE IV - MANNER OF ELECTION

The directors of the Corporation shall be elected in accordance with methods and qualifications specified in the bylaws of the Corporation. In no event, shall the number of directors be fewer than three.

ARTICLE VIII - NO PERSONAL BENEFIT

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III above. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the

corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(92) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX - DISTRIBUTION OF ASSETS

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
