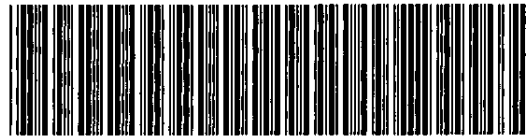

The Undersigned acting as Incorporators of a Non-Profit Corporation in compliance with Chapter 617, Florida Statutes Non-Profit Corporation Act adopts the following Articles of Incorporation.

Article I.

The name of the Corporation is: Coalition Force International, Inc.

Article II.

The principle address of Coalition Force International, Inc. is:

Article III.

The purpose for which Coalition Force International, Inc is organized is:

Section III.01 To operate exclusively for charitable, educational and religious purposes within the meaning of Section 501(c) 3 of the Internal Revenue Code of 1986, or corresponding section of any future tax code and generally to engage in any other lawful endeavor or activity in furtherance of any of the foregoing purposes.

Section III.02 Mission The Mission of Coalition Force International, Inc. is to:

A. Publicly proclaim the Gospel of Jesus Christ through preaching, teaching and exhortation. This includes musical, theatrical, artistic performances and multimedia presentations as well as radio and television broadcasting.

B. Establish a coalition for the interaction and sharing of associated ministers, ministries, churches, ministry organizations and Christian businessmen for the advancement of the Kingdom of God.

C. License, ordain, commission and provide, connectedness, accountability and support associated members, ministers, missionaries, religious workers, ministries, missions, churches and related organizations in their endeavor to advance the Kingdom of God.

D. Plant, establish, and strengthen churches, marketplace ministries, missions and kingdom businesses for the advancement of the Kingdom of God.

E. Conduct conferences, revivals and ministerial events for the edification, training and development of covenant relationship building and connectedness of associated ministers, religious workers, Christian businessmen, religious organizations and churches.

F. Developing ministerial schools for the teaching, training and spiritual development of the public, associated ministers, churches and related organizations.

G. Partnering participating with and supporting associated members, ministers, missionaries, religious workers, ministries, missions, churches and related organizations in their endeavor to advance the Kingdom of God.

H. Promoting, publishing or sponsoring publication of written materials in furtherance of the Kingdom of God.

I. Acquiring, constructing, maintaining, operating, improving, changing, repairing and purchasing land, facilities, buildings, leases, and land rights for the for use as temporary or permanent sites for the use of the organization its associated members, ministers, missionaries, religious workers, ministries, missions, churches and related organizations.

J. Contributing, lending or giving financial support to associated members ministers, missionaries, religious workers, ministries, missions, churches and related organizations for the advancement of the Kingdom of God and all other legal purposes.

K. Ministering to the physical, mental, and spiritual health and well-being of the public, associated members, ministers, missionaries, religious workers, ministries, missions, churches and related organizations.

L. To raise financial support by soliciting charitable donations, tithes and offering contributed by associated members, ministers, missionaries, religious workers, ministries, missions, churches and related organizations, in addition to by means of selling books, tapes, magazines, publications, written materials, video materials or other items related to the Christian lifestyle and the advancement of the Kingdom of God in any and all mediums.

M. To receive and maintain a fund or funds of real or personal property, both tangible or intangible, or both, and subject to the restrictions and limitations herein set forth to apply the whole or any part of the income therefrom and the principle part thereof exclusively for charitable, religious, scientific, literary, or educational purposes either directly or by contributions to the organization that qualify as exempt organizations under 501(c) 3 of the Internal Revenue Code and its regulations as they now exist or as they may be amended.

Section III.03 Vision The Vision of Coalition Force International, Inc. is to advance the Kingdom Of Jesus Christ throughout the earth by providing a base of operations for training and providing international evangelism, missions and humanitarian relief efforts around the globe.

Article IV.

The manner in which Directors are elected is:

Section IV.01 Election and Tenure. The initial Board of Directors shall be appointed by the incorporators and thereafter shall be elected by the Board of Directors at a regular meeting of the Board of Directors to be held at the principle office of Coalition Force International, Inc. or such other place, as may be fixed by the Board. Directors who are elected shall serve for a term of one (1) year, or until his or her successor is elected and qualifies, subject, however to the removal of any Director as allowed by applicable law or Coalition Force International, Inc.'s bylaws.

Section IV.02 Election: Nominating Committee. A Nominating Committee shall prepare a slate containing nominees for each board position and shall determine the eligibility and willingness of each nominee to stand for election. Candidates for Board positions may also be nominated by petition process established by the Nominating Committee or the Board.

Section IV.03 Discrimination during Elections. Discrimination in election and nominating procedures on the basis of race, color, creed, gender, age, marital status, national origin, physical or mental disability, or unlawful purpose is prohibited.

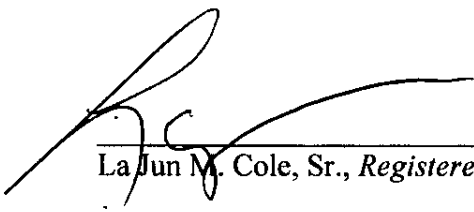

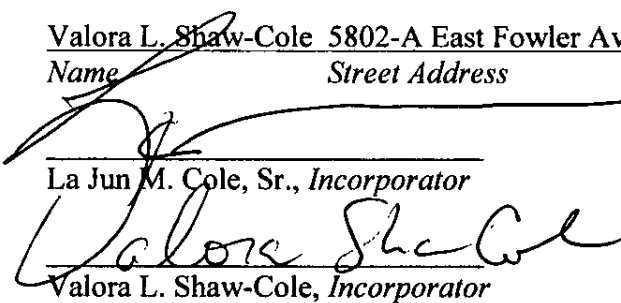

The duration of this corporation is perpetual and this document is effective upon filing with the Secretary of State.

Article IX.

The provision regarding the distribution of assets upon dissolution is:

Upon dissolution, after all creditors of Coalition Force International, Inc. have been paid, its assets shall be distributed to one or more organizations that qualify as exempt organizations under section 501(c) 3 of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for exclusively public purposes.

Article X.

The provision regarding liabilities for breach of duties is:

To the extent allowable by the laws of the State of Florida, no present or future Director of Coalition Force International, Inc. (or his or her estate, heirs and personal representatives) shall be liable to Coalition Force International, Inc. or its members for monetary damages for breach of fiduciary duty as a director of Coalition Force International, Inc. Any liability of a director (or his or her estate, heirs, and personal representatives) shall be eliminated or limited to the fullest extent allowed by the laws of the State of Florida, as may hereafter be adopted or amended.

Article XI.

The provisions regarding indemnification of directors or officers are:

With respect to claims or liabilities arising out of service as a director or officer of Coalition Force International, Inc., Coalition Force International, Inc. shall indemnify and advance expenses to each present and future director and officer (and his or her estate, heirs and personal representatives) to the fullest extent allowable by the laws of the State of Florida, both as now in affect and as hereafter shall be adopted or amended.
