Article I

The name of the corporation is: First Home Counseling Services, Inc.

Article II

Article III

- 3.1 The Corporation is organized exclusively for religious, charitable, scientific, literary, and educational purposes, all within the meaning of section 501(c)(3) of the internal Revenue Code of 1986, as amended from time to time (the "Code") or the corresponding provision of any subsequent federal tax law ("Section 501(c)(3)). Specifically First Home Counseling Services, Inc. is a non-profit organization that is established to providing an array of counseling services to families.

- E. Not engage in activities that are illegal or violate fundamental public policy.
- 3.3 Powers: Subject only to such limitations as now or hereafter are prescribed by law or in the Corporation or Bylaws, the Corporation shall have all power which now or hereafter are conferred by

Article X: Members

The corporation shall have members. Members of the corporation shall be required to meet the qualifications as set forth in the bylaws.

Article XI: Director Liability Limitations
