Articles of Incorporation of
The Central Florida Scorpions, Inc.**

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: The Central Florida Scorpions was established as an organization to promote and help develop the playing skills of young adult men in the sport of football. Not only for the possibilities of playing at a higher level, but also for the simple love of the game. The Central Florida Scorpions looks to be an active and positive force in the local community, providing our time and energy in such places as hospitals, churches, schools, nursing homes, and other community related organizations where positive attitudes, moral judgments, and healthy lifestyles are a way of living. Building good leadership roles, strong character, sportsmanship, and discipline will be the corner stone of our success. Although this will all be a challenging task, we feel it's important in today's hard times, that the young men involved in this organization have the opportunity to become productive and responsible adults on and off the playing field, so that they too can pass along their skills to future young men. While the Central Florida Scorpions are looking to establish a dominate program, no young man will be turned away regardless of skill level. Every young man who puts forth the effort and hard work will earn a chance to play.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of this organization shall be carrying on propaganda, or otherwise attempting to influence legislation, and this organization shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
