Article IV of the Articles of Incorporation is deleted and replaced as follows:

The sole member of the Corporation shall be First Baptist Church of West Palm Beach, Florida, a Florida corporation not-for-profit.

Section 2 of Article VIII of the Articles of Incorporation is deleted and replaced as follows:

2. The Board of Directors serving as of the date of this Amendment to the Articles of Incorporation shall serve until such Director, dies, resigns or is removed by two-thirds vote of the Board of Directors or by the member.

Any vacancy in the office of any Director shall be filled by the affirmative vote of a majority of the remaining Directors, even though less than a quorum of the Board of Directors.

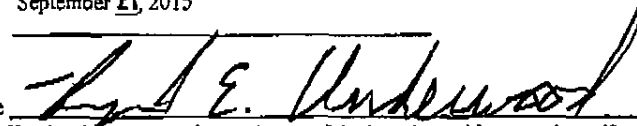
