

We are in receipt of your letter of June 1 regarding our recent filing. Thank you for noting that we did not list the street address for our officers; I've now added those addresses to your form as you requested.

As regards the Titles of officers, we've reviewed the website link that you suggested and we believe that the Titles that we wish to use are appropriate as submitted and fully consistent with Sunbiz guidelines. Your guidelines specifically state that the list of suggested titles "is not comprehensive. Other abbreviations may be used that are not identified" on the list. Further, your guidelines say that "we do not recommend using titles meant for any other business type other than your own."

Our church does not use a title such as "Vice President". Rather we use titles such as "Senior Warden (SW)" and "Junior Warden (JW)". Thus those are the titles we wish to use. Please note that other churches do the same in their filings. Several examples of this are Church of the Holy Spirit (N23096), Church of Bethesda by the Sea (N02554), Church of the Blessed Redeemer (N05000000881), etc.
