Ladies and/or Gentlemen:

Enclosed is our application to have our Corporation reinstated. We were informed that the Corporation had been dissolved on September 19, 2003 for failure to file an Annual Report. We learned this when we applied for our Solicitations permit with the Division of Consumer Services.

We never received the Annual Report Form. For years I have used my home address as the address for the League. I had moved and evidently the forwarding period had expired. To further complicate matters, about the time that the Report was due, I had surgery. In normal times, I may have realized that we had not received the report and followed up on the matter. However, my mind was evidently on my surgery.

The failure to file was not intentional and we are requesting reinstatement promptly upon learning of the delinquency. This administrative oversight on our part did not jeopardize any interest of the State. We respectfully request that the Reinstatement Fee be waived. This will allow us to use the funds to further our exempt purpose which is to provide assistance to victims of child and spouse abuse. Enclosed is our check in the amount of \$61.25 for the 200<sup>2003</sup> fee.

Please furnish us a 2004 Annual Report Form as soon as possible so that we may file it in a timely manner. Thank you for your consideration.
