- 1. NCOA Gateway Chapter 646, Inc. was established on October 10, 1985.
- 2. Every year since at least 1996, it has filed Annual Reports, which is evidenced through the filings available on Sunbiz.org.
 - 3. On January 12, 2022, NCOA Gateway Chapter 6 4 6 Inc., filed its annual report.
- 4. On August 6, 2022, NCOA Gateway Chapter 6 4 6 Inc., filed its amended annual report.
- 5. On September 20, 2022, NCOA Gateway Chapter 6 4 6 Inc., filed its amended annual report, which identified the following correct, and most recent duly appointed officers:
 - a. William David Smith, Chairman
 - b. Paul John Rizzo, Vice Chairman
 - c. Frank Saraceni, Trustee
 - d. Wesson Williams, Trustee
 - c. Tomothy Forry, Trustee

- f. Michael Bogmanko, Chaiplan
- 6. On September 21, 2022, without authority, an amendment was unlawfully filed by Sidney Korvun, incorrectly stating that the following were officers of NCOA Gateway Chapter 6
 - a. Sidney Korvun, President
 - b. Gerald Morey, CEO, and
 - c. Joe Terry, COO

- 7. On October 3, 2022, a Statement of Fact was received, dated September 21, 2022, which was filed by Sidney A. Korvun.
- 8. In the statement of fact, Sidney A. Korvun, who was not the duly appointed President of NCOA Gateway Chapter 6 4 6, Inc. and had no authority to change the Officers, Registered Agent, or amend any filings through the State of Florida associated with NCOA Gateway Chapter 6 4 6, Inc., falsely purported to be President of NCOA Gateway Chapter 6 4 6 Inc.
- 9. In the Statement of Fact, Sidney A. Korvun, who had no authority of or over NCOA Gateway Chapter 6 4 6, Inc., stated the following factually incorrect statement:

This is in response to the name change on said organization, NCOA Gateway Chapter 646. The change was made without my permission. As President of the Association, only I am able to make such changes, or someone of my choosing.

- 10. Korvun mad no indication as to what was meant by the name change, as NCOA Gateway Chapter 6 4 6, Inc., had not changed its name by any filing; however, had it chosen to do so, the duly appointed officers were lawfully permitted to make such change.
 - 11. Sidney A. Korvun is not the President of NCOA Gateway Chapter 6 4 6, Inc.
 - 12. Gerald Morey is not the CEO of NCOA Gateway Chapter 6 4 6, Inc.

- 13. Joe Terry is not the COO of NCOA Gateway Chapter 6 4 6, Inc.
- 14. The duly appointed Officers are filing another Amendment to the Annual Report to restore and make of record the correct information.
