

The following Articles of Incorporation have been amended as follows:

Article 1. Section 1. Was: The name of this organization shall be Alliance for the Mentally III of Brevard County, Inc.

Article 1. Section 1. Is: The name of this organization shall be NAMI Space Coast. Inc.

#### Article 4: Election of Officers

Was: The officers shall be elected by membership vote in the regular monthly meeting in the month of July of each year. All terms of office shall commence in September.

Is: The officers shall be elected by membership vote in the regular monthly meeting in the month of January of each year. All terms of office shall commence in February.

#### Article V. Quorum

Was: For the purpose of conducting organizational business at membership meetings, a quorum shall be one quarter of the paid membership.

Is: For the purpose of conducting organizational business at membership meetings, a quorum shall be 10 percent of the paid membership.

### Article VI: Amendment of Bylaws

Delete ", subject to section 2 of this article," of this paragraph. (there is no section 2)

Was: Dues of five dollars per family per year shall be payable on September 1 of each calendar year. Persons joining this organization ninety days or less prior to September 1 shall be considered as having paid for the coming calendar year.

Is: Dues of twenty dollars per family per year shall be payable by January 31 of each calendar year. Persons joining this organization ninety days or less prior to January 1 shall be considered as having paid for the coming calendar year.
