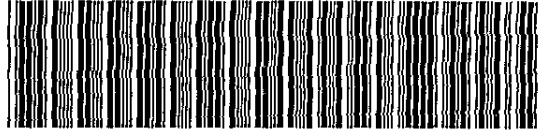



**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF  
VILLE DE CAPRI HOMEOWNERS' ASSOCIATION, INC.  
(A CORPORATION NOT FOR PROFIT)**

The Articles of Incorporation of VILLE DE CAPRI HOMEOWNERS' ASSOCIATION, INC., ("VILLE DE CAPRI") is hereby amended pursuant to approval of the Board of Directors and ratification of the membership by the affirmative vote of a majority of the membership of the Association pursuant to Article VIII of the Articles of Incorporation for VILLE DE CAPRI, dated October 17, 1985.

I. This Amendment hereby amends Article V, Section 1 of the Articles of Incorporation as follows:

"Section 1. Management by Directors. The property, business and affairs of the Association shall be managed by a Board of Directors, which shall consist of not less than ~~three~~five nor more than nine persons, but as many persons as the Board of Directors shall from time to time determine. A majority of the directors in office shall constitute a quorum for the transaction of business. The Bylaws shall provide for meetings of directors, including an annual meeting.

The number of directors may be changed by resolution adopted by the Board of Directors; provided, however, that the number of directors shall not be decreased to less than five (5). The directors elected by the members shall have staggered terms.

To accomplish the staggered terms, the following election procedure shall apply to the election of the five (5) directors by members at the 2005 annual meeting of members and election of Directors. The two (2) directors receiving the highest number of votes shall be elected for a two (2) year term. The three (3) remaining directors elected, shall be elected for a one (1) year term."

II. Except as amended and modified herein, all other terms and conditions of the Articles of Incorporation for VILLE DE CAPRI shall remain in full force and effect according to their terms.

III. This Amendment has been proposed and adopted by a majority of the membership of the Association which is sufficient for approval *on April 21, 2005.*
