**ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION OF  
ATLANTIC AND GULF COASTS DOCKING PILOTS ASSOCIATION, INC.**

ATLANTIC AND GULF COASTS DOCKING PILOTS ASSOCIATION, INC., pursuant to Section 617.1006, Florida Statutes, does hereby file the following Articles of Amendment:

1. That the name of the Corporation is ATLANTIC AND GULF COASTS DOCKING PILOTS ASSOCIATION, INC. The corporation was assigned document number N11664.

2. That Article I of the Articles of Incorporation of ATLANTIC AND GULF COASTS DOCKING PILOTS ASSOCIATION, INC. is hereby amended to read as follows:

**"ARTICLE I**

**CORPORATE NAME**

The name of the corporation is AMERICAN HARBOR AND DOCKING PILOTS ASSOCIATION, INC. This corporation shall hereinafter be referred to as the "Association".

3. That the foregoing amendment was adopted by the written consent of the members of ATLANTIC AND GULF COASTS DOCKING PILOTS ASSOCIATION, INC., in accordance with Article XI, Section I of Articles of Incorporation of ATLANTIC AND GULF COASTS DOCKING PILOTS ASSOCIATION, INC. and pursuant to Section 617.0701, Florida Statutes. The number of votes cast by the members was sufficient for approval. The date of adoption of this amendment was August 23, 1999.

4. These Articles of Amendment shall be effective as of August 23, 1999.
