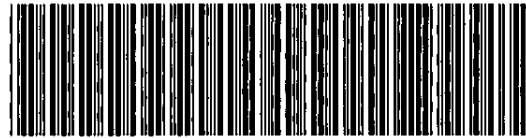

**ARTICLES OF INCORPORATION OF

ARTICLE I - NAME

The name of this corporation is South Dade Senior High School Class of 1972 40th Class Reunion, Inc.

ARTICLE II – ENABLING LAW

This corporation is organized pursuant to the corporation's not-for-profit law of the State of Florida, set forth in Part I of Chapter 617 of the Florida Statutes.

ARTICLE III – PRINCIPAL OFFICE

The address of the principal office of the Corporation shall be 11025 SW 223 Street, Goulds, FL 33170.

ARTICLE IV – PURPOSES

1. The specific and primary purpose for which this Corporation is organized is to plan and organize the 40th reunion event for the South Dade Senior High School Class of 1972.

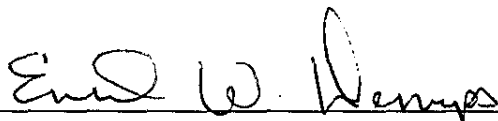

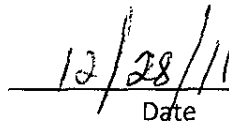
ARTICLES IX – AMENDMENTS OF ARTICLES OF INCORPORATION

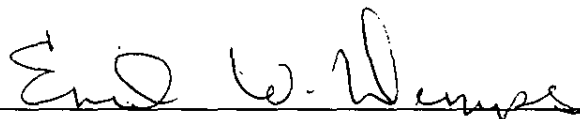

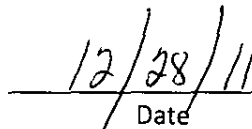
