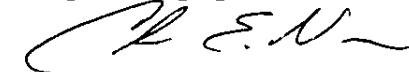

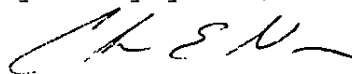

Articles of Incorporation of  
TITANS ATHLETIC BOOSTER CLUB, INC.,  
a Florida Not-For-Profit Corporation

The undersigned person, acting as incorporator of a corporation not for profit under the Florida Not-For-Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, adopt the following articles of incorporation for the corporation:

Article I.

The name of the corporation is TITANS ATHLETIC BOOSTER CLUB, INC.

Article II.

The corporation shall have a perpetual duration.

Article III.

The corporation is a not-for-profit corporation. The purposes for which the corporation is organized are:

(a) The specific and primary purposes for which this corporation is formed are to foster national amateur sports competition and assist in the teaching of sports to youths.

(b) The general purposes for which this corporation is formed are to operate exclusively for national amateur sports competition which will qualify it as an exempt organization under 26 U.S.C.A. § 501(c)(3), or corresponding provisions of any subsequent federal tax laws, including, for those purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Section.

(c) This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene by publication or distribution of any statements in any political campaign on behalf of any candidate for public office.

Article IV.

The corporation shall have a membership distinct from the board of directors. The authorized number and qualifications of the members of the corporation, the manner of their admission, the different classes of membership, if any, the property, voting, and other rights and privileges of members, and their liability for dues and assessments and the method of collecting

dues and assessments shall be as regulated in the bylaws.
