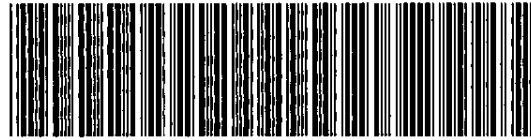



Article VIII: Dissolution

The Church Property:

- (1) In the event of a division of this ministry, the property of this ministry shall belong to that group of such division as represents the largest portion of the ministry membership, provided such group is loyal to this constitution; otherwise it shall belong to the group remaining loyal to this constitution though it may not be the largest group in such division.
- (2) Should a condition arise at any time in the future when for any reason, the ministry work cannot continue, the property shall be sold to retire any debt and the remaining proceeds shall be donated equally to save the children fund USA.
- (3) Should conditions arise where a consolidation with another Ministry or church of the same beliefs be advisable, the Team of officers shall be authorized by the ministry to negotiate the terms of such consolidation in so far as the properties of this ministry is concerned.
