

Upon liquidation or dissolution the corporate assets shall be distributed first in payment of all liabilities of the corporation and then exclusively for the purposes of the corporation or to charitable or educational organizations then exempt under Section 501 (c) (3) of the Internal Revenue Code of 1954 as amended.
