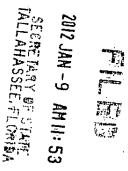

ADDENDUM TO ARTICLES OF INCORPORATION OF

CHRIST WORLD PRAYER CENTER, INC.

VIII

- a) This corporation is organized and operated exclusively for religious purposes within meaning of Section 501 (c) (3) of the Internal Revenue Code.
- b) Not-withstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Control or (2) by a corporation contributions to which are deductible under Section 170(c) (2) of the Internal Revenue Code.
- The property or of this corporation is irrevocably dedicated to Religious purpose and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer member thereof, or the benefit of any private person.
- On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a non-profit fund, foundation, or corporation, which is organized and operated exclusively for Religious, under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distribute to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
