ARTICLES OF INCORPORATIONS

- I) The name of the corporation shall be: Sembact Martial Arts, Inc.
- II) The place in this state where the principal office of the Corporation is to be located is, The City of Fort Myers, Lee County.

- III) Said corporation is organized exclusively for educational, literary, and purposes, including, for such purposes, the making of distributions to organizations that Qualify as exempt organizations under section 501(c)3 of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- The specific purpose of our organization is to provide intervention and prevention programs that focuses on discipline, conflict resolution, personal and professional development to at-risk youth and young adults to help decrease violence among those high risk groups by utilizing Martial Arts.
- IV) No part of the net earnings of the corporation shall insure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. Now substantial part of the activities of the corporation shall be the carrying of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) 3 of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- V) Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
