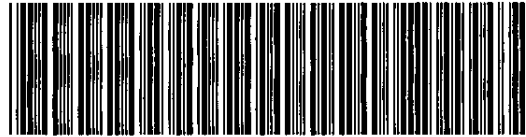

Article III: Purpose

The purpose of Christ The King Baptist Church, Inc. is exclusively religious, charitable, and educational within the meaning of section 501 (c)(3) of the Internal Revenue code or the corresponding provision of any future United States Internal Revenue Law.

The purpose shall also be to cultivate, promote, promulgate and extend the teachings and precepts of Jesus Christ. In addition, to maintain a Biblical Christian Church, providing a place to worship, establishing other churches in other cities, states and international locations. Furthermore, it shall be our purpose to establish, maintain and conduct schools for the academic and religious instruction of the young. We will also perform other charitable works such as: substance abuse prevention and counseling, addressing homelessness and food insecurity, services for the elderly as well as individuals and families in crises.

Article IX: Limitations

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501 (c)(3)

Article X: Dissolution

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
