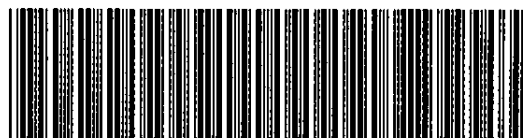

ARTICLE III PURPOSE:
