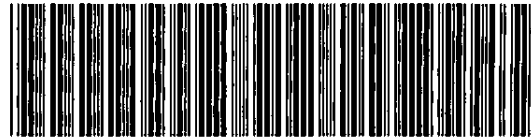

**ARTICLES OF INCORPORATION**

In compliance with Chapter 617, F.S., (Not for Profit)

**ARTICLE I NAME**

The name of the corporation is Creativeworkz By Design, Inc.

**ARTICLE II PRINCIPAL OFFICE**

11120 Caroline Crest Dr.  
Jacksonville, FL 32277

**ARTICLE III PURPOSE**

The purpose for which Creativeworkz By Design, Inc. is organized and operated is exclusively for charitable and educational purposes as defined by Section 501 (c)(3) of the Internal Revenue code of 1986, including, but not limited to:

- (a.) Providing community services to the public which are beneficial to the residents of the community
- (b.) Providing access to educational resources (such as books, computers, referrals to assistance programs,) to children and adults who have difficulty in obtaining access to these resources on their own.
- (c.) Educating members of the community in the areas of health, finance, and emotional well being.
- (d.) Aiding, supporting, and assisting by gifts, grants, contributions, or otherwise, other persons or organizations for which a need is identified, provided that such activities are consistent with the forgoing purposes of CreativeWorkz By Design, Inc.
- (e.) Providing protection to the community by providing a safe haven (such as a community center) for children in unsafe neighborhoods.

CreativeWorkz By Design, Inc. shall have all powers now, or hereafter granted by law, and all powers lawfully necessary or required to carry out its purposes, either alone or in corporation with others, subject to such limitations and conditions as are prescribed by law, or in CreativeWorkz By Design bylaws.

All of the powers of CreativeWorkz By Design, Inc. shall be exercised exclusively for charitable and educational purposes in such manner that shall qualify as an exempt organization under Section 501 (c)(3) of the Internal Revenue code of 1986.

No part of the activities of CreativeWorkz By Design, Inc. shall be the carrying on of propaganda or otherwise attempting to influence legislation, except as otherwise permitted to an organization described in section 503 (c)(3) of the Internal Revenue code of 1986. CreativeWorkz By Design shall not participate in or intervene in any political campaign on behalf of (or in opposition to) any candidate for public office.

Notwithstanding any other provisions of these Articles, CreativeWorkz By Design, Inc., shall not carry on any activities not permitted to be carried on (a.) by a corporation exempt from federal and state income taxes under Section 501 (c)(3) of the Internal Revenue Code of 1986 or any successor provision, or (b.) by a corporation, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code or any successor provision.

No part of the net earnings of CreativeWorkz By Design, Inc. shall inure to the benefit of or be distributable to its directors, officers, or other private persons, except that CreativeWorkz By Design, Inc. is authorized or empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of its purposes.

**Upon Dissolution of CreativeWorkz By Design, Inc.,** the net assets will be distributed as follows: The assets of CreativeWorkz By Design, Inc., remaining after payment of or provision for payment of all debts and liabilities of CreativeWorkz By Design, Inc. shall be distributed to an organization or organizations, as determined by the Board of Directors, that are recognized as exempt under Section 501 (c)(3) of the Internal Revenue Code of 1986, and used exclusively to accomplish the purposes for which CreativeWorkz By Design, Inc. is organized.

**ARTICLE IV MANNER OF ELECTION**

The manner of election or appointment of any subsequent Directors of CreativeWorkz By Design, Inc. after the initial Directors, shall be set in the Bylaws of CreativeWorkz By Design, Inc. The initial Board of Directors, hereinafter named, shall be appointed by the Incorporator, Lisa Corprew. The initial Directors will serve a term of four (4) years, after which, Directors will be elected or re-elected every four (4) based on the Bylaws of CreativeWorkz By Design, Inc.


