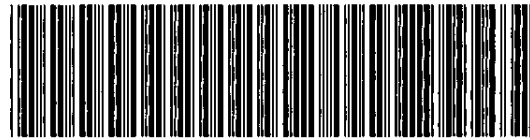

**ARTICLE I-NAME**

The name of this corporation is Tampa Bay Soccer Supporters Alliance, Inc.

**ARTICLE II-PRINCIPAL PLACE OF BUSINESS**

The principal place of business of the corporation is Tampa, Hillsborough County, Florida. The mailing address of the corporation is 1717 West Hills Ave., Tampa, FL 33606. Both the principal place of business and the mailing address of the corporation may be changed by appropriate amendment with the Secretary of State.

**ARTICLE III-PURPOSE**

The purpose of the corporation will be a fan club supporting professional soccer in Tampa Bay and related charitable endeavors.

**ARTICLE IV-ELECTION OF OFFICERS**

Officers will be elected annually from a vote of the directors of the corporation.

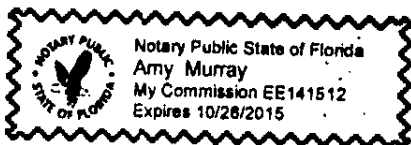
