ARTICLES OF INCORPORATION OF

HAITIAN HEROES, INC.

(Not For Profit Corporation)



The undersigned subscriber, for the purposes of forming a corporation not for profit under the Florida Not for Profit Corporation Act, hereby subscribes to, acknowledges and files the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation shall be HAITIAN HEROES, INC.

ARTICLE II – ADDRESS

The principal mailing address of the corporation shall be 6212 FOREST HILL BLVD, # 101, WEST PALM BEACH, FL 33415. Such address may be revised from time to time by the Board of Directors at any regular meeting or special meeting called for that purpose.

ARTICLE III – TERM OF EXISTENCE

This Corporation is to exist perpetually. The existence of the corporation shall be deemed to commence on the date these articles are filed with the Florida Department of State, unless dissolved according to laws.

ARTICLE IV - PURPOSES

The Corporation shall be organized exclusively for charitable, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. As such, the principal objectives and purposes for which the corporation is organized are as follow:

- A. To promote academic and social advancement within Haitian communities.
- B. To advocate, promote, and present cultural events with an emphasis on Haitian culture and arts, and to engage in all activities as allowed by laws, and so far as permitted by the section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or to corresponding provisions of future federal tax legislation.
- C. To promote health and prevent diseases among all Haitians by providing health care services, housing, counseling, information, health education, and all types of lawful support services that will result in healthy Haitian communities, increase life expectancy, and improve the quality of life among Haitians.

- D. To provide food and all necessary resources to identified poor and at risk families as permitted under the law of Florida and the United States of America and beyond.
- E. To advocate, promote and support the expansion and success of all startup, emerging, and mature Haitian-owned businesses by providing an array of services including training, technical assistance, administrative assistance, financial assistance, and other ancillary support services.
- F. To do everything necessary, convenient, suitable, or proper for the accomplishment, attainment, or furtherance of; to do every other act or thing incidental to, appurtenant to, growing out of, or connected with the purposes and objectives set forth in the Articles of Incorporation, whether alone or in association with others, as allowed by laws, and as permitted by the section 501(c)(3) of the Internal Revenue Code; to possess all the rights, powers, and privileges now or hereafter conferred by law upon a not for profit corporation organized under the laws of Florida. United States of America, and beyond as permitted by the section 501(c)(3) of the Internal Revenue Code.

To accept, hold, invest, reinvest, use, expend, disburse, and administer any gifts or grants, without limitations as to origin, amount or value, and to use, expend, disburse, or donate the income or principal thereof for charitable, educational, and scientific purposes consistent with the Corporation's purposes.

ARTICLE V - MANAGEMENT

The Corporation's affairs shall be managed by the Board of Directors. This Corporation shall have between three (3) and seven (7) directors. The number of Directors may be increased or decreased from time to time, in accordance with the Bylaws but shall never be less than the minimum required by law or more than seven (7).

ARTICLE VI – MANNER OF ELECTION

The Directors of the Corporation shall be a President, Vice-President, Vice President-Cultural Affairs, Secretary, Treasurer and such other officers as may be provided in the Bylaws. The manner in which the directors are elected or appointed shall be done in accordance with the corporation's bylaws.

ARTICLE VII - BYLAWS

The Board of Directors of this Corporation shall adopt Bylaws for the conduct of the Corporation's affairs and the carrying out of its purposes as may deem necessary. The Bylaws may be amended, altered or rescinded by the Board of Directors of this corporation at any regular meeting or special meeting called for that purpose.
