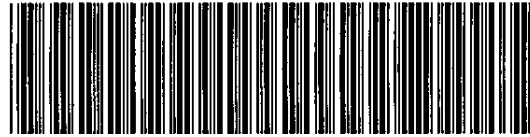

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- The purpose for which this congregation is formed is to represent and serve as a part of the living Body of Christ in the world:
1) Proclaiming the Good News of Jesus Christ in faithful obedience to the will and purposes of God, so that His love may be received, His Word obeyed, and His Church expanded to all the world.
2) Recruiting Disciples, teaching them and training them to grow in the knowledge of the will of God as revealed in the Gospel of Christ, facilitating their understanding of the implications of the Gospel for their lives, and challenging them to a commitment of faith and exercising Christian discipleship. 3) Providing opportunities to grow and develop spiritually by way of worship, the practice of Christian disciplines, and diverse experiences of life in Christian community. 4) Serving the community of which the church is a part. 5) Serving with a prophetic voice against the advance of immorality and injustice in society.

7) The church shall be a non-profit organization that serves charitable and educational purposes.

The manner in which the directors are elected and appointed:

Election and terms of Office

1. The members of the Administrative Board (Board of Directors) shall be elected by the Congregational Annual Assembly by simple majority 2. They shall serve a term of two years.
3. In cases where no acceptable candidates are available, the Congregational Assembly may extend their term annually.
